

## The nomination committee's proposal for the Board of Directors etc.

The nomination committee has proposed the following to the Annual General Meeting:

- <u>that</u> the number of ordinary members of the Board of Directors shall amount to five with no deputies;
- <u>that</u> the following persons are re-elected as ordinary members of the Board of Directors until the end of the next AGM: Pascal Chevalier, Gautier Normand, Nils Carlsson, Jérémy Parola and Erik Siekmann;
- that Pascal Chevalier is re-elected chairman of the Board of Directors;
- that EY AB is re-elected as auditor until the end of the next AGM;
